ENTERING CROATIA



PERSONS COMING FROM THE COUNTRIES AND/OR REGIONS OF THE EUROPEAN UNION AND/OR REGIONS OF THE SCHENGEN AREA AND THE COUNTRIES ASSOCIATED WITH THE SCHENGEN AREA (EXCEPT FROM REGIONS MARKED GREEN ON THE ECDC MAP) CAN ENTER CROATIA PROVIDED THAT THEY MEET ONE OF THE FOLLOWING CRITERIA:

- ✓ Providing **negative PCR or rapid antigen test** for SARS-CoV-2 listed on the EU Joint List of Rapid Antigen Tests, if the test result is **not older than 48 hours** from the time of testing to arrival at the border crossing.
- ✓ Providing **vaccination certificate at least 14 days old** for persons who received the second dose of COVID-19 vaccine; or vaccination with single dose, in the case of a single dose vaccine
- ✓ Providing **positive PCR or rapid antigen test, confirming recovery from SARS-CoV-2 virus infection**, between **180 days and 11 days old**, or providing valid certificate of recovery from illness issued by a medical doctor.

If none of the conditions above are met, self-isolation upon arrival in the Republic of Croatia is required with the possibility of PCR or rapid antigen testing for SARS-CoV-2, and in case of impossibility of testing self-isolation lasts 10 days

CHILDREN under the age of seven traveling with a parent/guardian are exempt from presenting a negative test result and self-isolation if the parents/guardians comply with the conditions listed above.



PERSONS COMING FROM THIRD COUNTRIES (non-EU, non-SCHENGEN) CAN ENTER CROATIA IF TRAVELING FOR TOURIST REASONS WITH A VALID CERTIFICATE OF PAID ACCOMMODATION IN A HOTEL, CAMP, VACATION RENTAL OR BOAT CHARTER OR OTHER FORM OF TOURIST ACCOMMODATION OR PROOF OF OWNERSHIP OF HOUSE/FLAT OR VESSEL IN CROATIA, PROVIDED THAT THEY MEET ONE OF THE FOLLOWING CRITERIA:

- ✓ Providing **negative PCR or rapid antigen test** for SARS-CoV-2 listed on the EU Joint List of Rapid Antigen Tests, **not older than 48 hours** from the time of testing to arrival at the border crossing.
- ✓ Providing **vaccination certificates at least 14 days old** for persons who received the second dose of COVID-19 vaccine, or vaccination with single dose, in the case of a single dose vaccine
- ✓ Providing **positive PCR or rapid antigen test, confirming recovery from SARS-CoV-2 virus infection**, between **180 days and 11 days old** or providing valid certificate of recovery from illness issued by a medical doctor

THIRD-COUNTRY NATIONALS WHO HAVE APPLIED FOR RESIDENCE AND WORK, INCLUDING DIGITAL NOMADS, PROVIDED THAT THE COMPETENT AUTHORITY HAS TAKEN A POSITIVE DECISION ON THEIR APPLICATION, AND THIRD-COUNTRY NATIONALS TRAVELING FOR BUSINESS REASONS OR WHO HAVE OTHER ECONOMIC INTEREST ENTER CROATIA PROVIDED THAT THEY MEET ONE OF THE FOLLOWING CRITERIA:

- Providing **negative PCR or rapid antigen test** for SARS-CoV-2 listed on the EU Joint List of Rapid Antigen Tests, **not older than 48 hours** from the time of testing to arrival at the border crossing.
- Providing **vaccination certificates at least 14 days old** for persons who received the second dose of COVID-19 vaccine, or vaccination with single dose, in the case of a single dose vaccine
- Providing **positive PCR or rapid antigen test, confirming recovery from SARS-CoV-2 virus infection**, between **180 days and 11 days old** or providing valid certificate of recovery from illness issued by a medical doctor

If none of the conditions above are met:

- self-isolation upon arrival in the Republic of Croatia with the possibility of PCR or rapid antigen testing for SARS-CoV-2, and in case of impossibility of testing self-isolation lasts 10 days
- **CHILDREN under the age of seven** traveling with a parent/guardian are exempt from presenting a negative test result and self-isolation if the parents/guardians comply with the conditions listed above.
